#### 4. Notes to the balance sheet

#### 4.1 General information

euroCRIS is a not-for-profit association with offices in Nijmegen, The Netherlands, that brings together experts on research information in general and research information systems (CRIS) in particular. The organization has 96 paying members (2022: 307 paying and non paying members), mainly coming from Europe, but also from some countries outside of Europe.

Breakdown of the 96 (2022 between brackets) members:

79 (171) institutional members, number of paying members 2022 is 63 members

17 (136) personal members, number of paying members is 2022 is 15

96 (307)

Since the beginning of 2023 only actual paying members are considered to be Eurocris members..

On top of that there are 6 honorary members and 12 strategic partners .

#### 4.2 Summary accounting policies

Assets and liabilities are in general valued at historical cost. If no specific valuation principle has been stated, valuation is at historical cost.

Work in progress is valued at cost incurred at year end, minus invoiced amounts.

The result is the difference between the realizable value of the goods/services provided and the costs and other charges during the year.

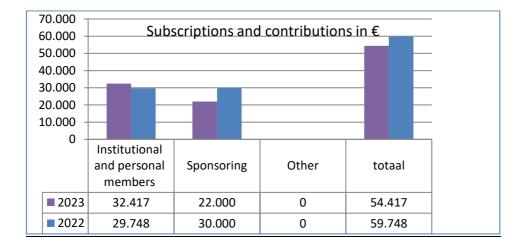

Eurocris has a one year contract with the Radboud University regarding secretary and office support (0,1 fte) and a one year contract with Pablo de Castro regarding secretary activities for the board (0,2 fte).

The costs in 2023 are higher, compared to 2022. In 2022 the costs of the administrative secretary re 2021 were not charged tot Eurocris, although the costs were taken into account in 2021. On top of that in 2022 the costs consists of 7 months the administrative secretary and 3 months a student assistant . In 2023 there is a normal cost level to be seen.

The other board cost include cost incurred by changing statutes ( $\in$ 1.166) and a honorary badge for the former president ( $\in$  1.090).
